The southern line then bounds the village in varying depths from the greens to include the Manor House, playing fields, Church Farm, the school and Union Chapel, Lime Tree Farm plus houses and land through to the Ridge. The line then contains the deep verge and mature hedgerows adjoining Plough Lane and crosses Plough Lane cutting out the unsympathetic ribbon development east of the Plough Inn.

The boundary then returns in varying depths to include the whole of the village north of the 3 greens to a point further north at the road junction by New House Green, but not to include the council houses and private developments to the rear of the Hit or Miss Public House, continuing to the farthest point north opposite Langley Gate Farm on the A.420, and including the mature horse-chestnut trees.

WEST RIDING OF YORKSHIRE COUNTY COUNCIL NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1971, SECTION 210

*Stainforth Thorne proposed (5-9) School
Bridleway Order, 1972*

On the 23rd January 1973 the West Riding Education Committee acting pursuant to powers delegated to it by the County Council of the West Riding of Yorkshire confirmed the above-named Order.

The effect of the Order as confirmed is to divert part of the bridleway leading in a northerly direction across the Stainforth Thorne Proposed (5-9) School site as shown by a bold black line on the map contained in the Order and marked A-B a distance of 107 lineal yards, and create an alternative highway in lieu along the northern and eastern boundary of the said site as shown by bold black dashes on the said map and marked B-C-D a distance of 137 lineal yards.

A copy of the Order and the map contained in it has been deposited at the Offices of the Thorne Rural District Council, Council Offices, Ellison Street, Thorne, via Doncaster, and may be inspected free of charge at all reasonable hours on Mondays to Fridays.

The Order becomes operative as from the date of confirmation thereof but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein, on the grounds that it is not within the powers of the Town and Country Planning Act, 1971, or on the grounds that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order he may under Section 244 of the Town and Country Planning Act, 1971, within six weeks from the date of the publication of this Notice make application for the purpose to the High Court.
