And whereas the Secretary of State is satisfied that it is expedient to suspend the withdrawal of the said authorities from the said Charles William John Hunt:

Now therefore, the Secretary of State hereby suspends, in pursuance of the powers conferred upon him by Regulation 22 of the said Regulations, the said withdrawal of authorities from the said Charles William John Hunt, and further suspends the operation of the said direction regarding prescriptions given by the said Charles William John Hunt.
