Notice is hereby given that by an order made on Monday the 12th day of February 1973 upon the petition of Edgar John Bullman of 42 Forest Lane Chigwell in the County of Essex a creditor of the above named company (hereinafter called the company) on the 21st December 1972 preferred unto this Court

And upon hearing counsel for the petitioner and for the Registrar of Companies (one of the respondents) and no one appearing for or on behalf of the company (the remaining respondent) although it has in the opinion of this Court been sufficiently served with the said petition pursuant to an order for substituted service dated the 22nd January 1973.

And upon reading the said petition the affidavit of Edgar John Bullman filed the 22nd January 1973 and the affidavit of Ivan Liddell filed the 8th February 1973 and the exhibits in the said affidavits respectively referred to

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Ivan Liddell and the Exhibit marked ILI thereto

And the petitioner by his counsel undertaking to use his best endeavours (a) forthwith to draw to the attention of the Company its breach of statutory duties as to annual returns, a notice of any change in the situation of the registered office of the Company a return of any changes among the directors or secretary and date of such change and a return of allotments and (b) to ensure that within two months of the restoration of the name of the Company to the Register of Companies the Company shall forward to the Registrar of Companies as required by sections 124 and 126 of the above mentioned Act a copy of the annual return of the company for the year 1971 together with the documents annexed thereto as required by section 127 of the said Act give to the Registrar of Companies as required by section 107 of the said Act notice of any change in the situation of the registered office of the company send to the Registrar of Companies as required by section 200 of the said Act a return containing the particulars specified in the register of directors and secretaries of the Company and a notification of any change among the directors of the Company or in its secretary or in any of the particulars contained in its said register specifying the date of the change and deliver to the Registrar of Companies as required by section 52 of the said Act a return of allotments

This Court doth order that the name of the above named Grayspur Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Grayspur Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this order in his official name in the *London Gazette*

And it is ordered that the petitioner, the said Edgar John Bullman do pay to the Registrar of Companies his costs of the said petition
