DEPARTMENT OF THE ENVIRONMENT

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 211 of the above Act to authorise the stopping up of lengths of Brinsworth Lane, Marsh Street, Marsh Road and Marsh Lane at Rotherham, Yorkshire, in the interests of the safety of users of and to facilitate the movement of traffic on the Rotherham Inner By-Pass road (Stage 3) (which is a highway to be constructed in accordance with planning permission granted under Part III of that Act).

The proposed Order will require the provision of new highways maintainable at the public expense, for which the highway authority is to be the Rotherham County Borough Council.

During 28 days from the 11th May 1973 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Municipal Offices, Howard Street, Rotherham, and may be obtained free of charge from the Department of the Environment (quoting DYH 308/35/1/012) at the address stated below.
