NOTICE OF APPLICATION TO VARY A LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Yorkshire River Authority by James Dyson & Sons Limited to vary the licence (serial number 2/27/11/45) to abstract water from a borehole at Linthwaite, near Huddersfield, Yorkshire (map reference 098/146).

The variation applied for is: 10,000 galls. per hour, 100,000 galls. per day, 30,000,000 galls. per annum.
