Notice is hereby given that The City Council of Liverpool propose to make the following Orders under sections I (1) (2) and (3) and 84 D(1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968:—

1. (Prescot Road/ Holly Road) (Prohibition and Restriction of Waiting) Order

- To revoke the Orders specified in column I of Schedule 1 to this notice to the extent specified in column 2 of the said Schedule.
- To prohibit, with certain exceptions, the waiting by vehicles at any time in any of the lengths of road specified in Schedule 2 to this notice.
- To revoke the City Council of Liverpool (Hall Lane) Prohibition of Waiting) Order, 1969.
- 2. To prohibit any vehicle from proceeding in any of the lengths of Connaught Road specified in column 1 of Schedule 3 to this notice otherwise than in the direction specified opposite such lengths of road in column 2 of the said
- 3. To prohibit any vehicle from entering or leaving:—
 Guelph Street, Edinburgh Road,
 Renfrew Street, Teck Street and
 Battenberg Street in the City of Liverpool at their respective junctions with Hall Lane.
 - To prohibit any vehicle proceeding in any of the lengths of road specified in column 1 of Schedule 4 to this notice in the direction specified in relation to those lengths of road in column 2 of the said Schedule from making other than a right hand turn on reaching the junction specified in relation to those lengths of road relation to those lengths of road in column 3 of the said Schedule.
- To prohibit, with certain exceptions, the waiting by vehicles at any time in any of the lengths of road or sides of lengths of road specified in Schedule 5 to this notice.

To prohibit any vehicle from entering or leaving Arundel Street or Chepstow Street at their respective junctions with Carisbrooke Road.

To prohibit any vehicle from proceeding in that length of Aighburth Drive which extends from its junction with Ullet Road to a point 46 metres (151 feet) southeast of that junction otherwise than in a northwesterly direction.

- To prohibit any vehicle from proceeding in Hanson Road other-wise than in a southwesterly direction.
- 2. To prohibit, with certain exceptions, the waiting by vehicles at any time on the sides of lengths of road or in any of the lengths of road specified in Schedule 6 to this notice.
- To revoke the City Council of Liverpool (Traffic Regulation) . 11.

- 2. To prohibit any vehicle from proceeding, in Rainford Square otherwise than in a northerly direction.

 To prohibit any vehicle from proceeding in any of the lengths of roads specified in Schedule 7 to this notice.
 - To revoke the Orders specified in column 1 of Schedule 8 to this notice to the extent specified opposite such Orders in column 2 of the said Schedule.
 - 2. To prohibit, with certain exceptions, the waiting by vehicles at any time in any of the lengths of roads or sides of lengths of roads specified on Schedule 9 to this notice.

The exceptions referred to will enable a vehicle to wait for so long as is necessary (a) for a person to board or alight from the vehicle, (b) to enable the vehicle to be used in connection with any wedding, funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, (c) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of road, or sides of lengths of road, and (d) to enable goods to be loaded on to or unloaded from the vehicle, provided that no vehicle (other than a vehicle being used for the purposes of delivering or collecting postal packets as defined in section 87 of the Post Office Act, 1953) shall so wait between the hours of 8.00 a.m. and 9.30 a.m., and 4.30 p.m. and 6.00 p.m. on Mondays to Saturdays inclusive, in the lengths of road and side of length of road specified in Schedule 10 to this notice. The exceptions referred to will enable a vehicle to wait Schedule 10 to this notice.
