

HERTFORDSHIRE COUNTY COUNCIL

*The County of Hertford (Grosvenor Road, Borehamwood)
(Prohibition of Waiting) Order 1973*

Notice is hereby given that on 8th June 1973 the Hertfordshire County Council made an Order under the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 the effect of which is to prohibit the waiting of vehicles between the hours of 8 a.m. and 6.30 p.m. on Monday to Saturday inclusive on the following length of road at Borehamwood in the Rural District of Elstree:

Grosvenor Road—both sides—from a point 315 feet north-west of its junction with Shenley Road to the end of the cul-de-sac.

Exemptions are provided in the Order for:

1. picking up and setting down passengers;
2. loading or unloading of goods;

and where necessary in connection with:

3. the maintenance of the roads;
4. the supply of gas, electricity and water.

A copy of the Order and a plan showing the roads to which the Order relates may be inspected at Elstree Rural District Council Offices, Shenley Road, Borehamwood, Herts. and at Room 122, County Hall, Hertford.

This Order will come into operation on 2nd July 1973.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 8th June 1973 apply to the High Court for this purpose.

HERTFORDSHIRE COUNTY COUNCIL

*The County of Hertford (Various Roads, Royston)
(Prohibition and Restriction of Waiting) Order 1973*

Notice is hereby given that the Hertfordshire County Council propose to make an Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit and restrict the waiting of vehicles in Royston as follows:

1. 8.30 a.m. to 6.30 p.m., Monday to Saturday

Garden Lane (north side), from its junction with the Warren for a distance of 43 yards.

Jepps Lane (both sides), from its junction with Fish Hill westwards for a distance of 37 yards.

Lower King Street,

(west side), between its junction with Baldock Street and its junction with Kneesworth Street, a distance of 128 yards.

(east side), from a point 32 yards north of its junction with Baldock Street to its junction with Kneesworth Street, a distance of 96 yards.

2. Waiting allowed for a period of 1 hour in any 2 hours, 8.30 a.m. to 6.30 p.m., Monday to Saturday, inclusive

Fish Hill (west side), from a point 77 yards south of its junction with Church Lane southwards for a distance of 74 yards.

Lower King Street (east side), from its junction with Baldock Street northwards for a distance of 32 yards.

Southernmost road linking Fish Hill and Market Hill (north side), from its junction with Fish Hill to its junction with Market Hill.

Exceptions will permit waiting for the purposes of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods,

and where necessary in connection with

- (c) the maintenance of the roads; and
- (d) the supply of gas, electricity and water;
- (e) disabled drivers will be exempt from the limited waiting restrictions as indicated in item 2 above;

(f) Hackney Carriages while waiting at a duly authorised cab rank in the following length of road:

Market Hill (east side), from a point 10 yards south-east of its junction with John Street to a point 26 yards south-east of that junction.

"The County of Hertford (Baldock Street and Lower King Street, Royston) (Prohibition of Waiting) Order, 1958" and "The County of Hertford (Various Streets, Royston) (Prohibition of Waiting) Order, 1967" will be amended.

A copy of the proposed Order and a plan showing the roads to which the Order relates together with a statement of the reasons for proposing to make the Order may be inspected at the offices of the Royston Urban District Council, Council Offices, Town Hall, Royston, and at Room 122, County Hall, Hertford.

Objections to the proposal must be made in writing to the undersigned by 2nd July 1973, stating the grounds on which they are made and quoting reference 39.04/973.

KENT COUNTY COUNCIL

*The County Council of Kent (Various Roads, Wateringbury)
(Prohibition of Waiting) Order*

Notice is hereby given that the Kent County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, to prohibit the waiting of vehicles at all times at Wateringbury:

- (a) Bow Road (B.2015) from Tonbridge Road southwards
 - (i) for 138 yards on the east side and (ii) for 70 yards on the west side.
- (b) Red Hill from Tonbridge Road north-eastwards
 - (i) for 50 yards on the south-east side and (ii) for 70 yards on the north-west side.
- (c) Tonbridge Road (A.26) from 67 yards east to 60 yards west of the centre of Red Hill.

Exceptions will be provided in the Order to enable a vehicle to wait with police permission or for passengers to board or alight, for the loading or unloading of goods, for enabling works to be carried out in or adjacent to the road and for disabled persons.

A copy of the proposed Order, an explanatory statement and a map showing the roads concerned may be inspected during normal office hours either at Room 146, County Hall, Maidstone, or at the offices of the Malling Rural District Council, 123 High Street, West Malling.

*The County Council of Kent (Manston Road, Manston,
Minister) (Prohibition of Waiting) Order*

Notice is hereby given that the Kent County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to prohibit the waiting of vehicles at all times in Manston Road (Class III), Manston, from its junction with Route B.2050 for 635 yards north-eastwards.
