The North Shropshire Rural District Council (Footpath Nos. 54-55 Ellesmere) Public Path Diversion Order (No. 1) 1973.

Notice is hereby given that on the 20th June 1973, the North Shropshire Rural District Council confirmed the above-named Order.

The effect of the Order as confirmed is:

To divert the public right of way known as footpath (a) No. 54 Ellesmere running from its junction with the No. 54 Ellesmere running from its junction with the unclassified highway in the north-western corner of field No. 3054 on Shropshire Sheet XIII 7 in an easterly direction across field Nos. 3054, 3062 and 3064 to a point on the northern boundary of field No. 3064A to a line running from a point on the western boundary of field No. 3054, abutting the unclassified highway in a southerly then easterly direction along the western and southern boundaries of field No. 3054 and crossing into field No. 3122, and running along the northern boundary of that field until it crosses into field No. 3062, and runs in an easterly then

- (b) To divert the public right of way known as footpath No. 55 (The Lyth) Ellesmere, running from a point on the eastern boundary of field No. 3062, on Shropshire Sheet XIII 7, in a north-westerly direction to a point on the northern boundary of that field to a line runfield No. 3062, along the eastern and northern boundary of field No. 3062, along the eastern and northern boun-daries of that field to the point on the northern boundary where it rejoins the existing route of public footpath No. 55 (The Lyth) Ellesmere.
- (c) To divert the public right of way known as Foot-path No. 55 (Birch Hall) Ellesmere, running from the north-western corner of field No. 3051 on Shropshire north-western corner of held No. 3051 on Shropshire Sheet No. XIII 7 abutting the unclassified highway in a south-easterly direction along the north-eastern boundary to a point near the north-eastern corner of that field to a line running from a point on the western boundary of field No. 3051 abutting the un-classified highway and directly opposite the existing route of public footpath No. 55 in an easterly direction to a point near the north-eastern corner of that field where it rejoins the route of the existing Public Foot-path No. 55 (Birch Hall), Ellesmere.

The Order becomes operative as from the 30th July 1973, but if any person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act, 1959, as amended or on the ground that any requirements of the Act, as amended or of any regulation made thereunder has not been complied with in relation to the Order, he or she may under paragraph 2 in relation to the Order, he or she may, under paragraph 2 of the Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act within 6 weeks from the 29th June 1973, make an application for the purpose to the High Court.
