SOLIHULL COUNTY BOROUGH COUNCIL CLEAN AIR ACT 1956

The Solihull Smoke Control Order (No. 18) 1973

Notice is hereby given that the Solihull County Borough Council in exercise of the powers conferred on them by section 11 of the above-mentioned Act on the 5th July 1973, made an Order entitled "The Solihull Smoke Control Order (No. 18) 1973", declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation Environment for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act, if on any day after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before

lst May 1974, or before a later date determined by the Secretary of State for the Environment. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Department, Council House, Solihull, at all reasonable times during the period of six weeks from 28th July 1973.

Within the said period any person who will be affected by the Order may, by notice in writing to the Secretary of State for the Environment, 2 Marsham Street, London, SW1P 3EB, object to the confirmation of the Order.
