ROYAL WARRANT OF PRECEDENCE

THE IMPERIAL SOCIETY OF KNIGHTS BACHELOR

By Royal Warrant bearing date the 19th day of July 1973 Her Majesty The Queen has given and granted unto Knights Her Majesty The Queen has given and granted unto Knights Bachelor Royal Licence and Authority that they may henceforth wear the Badge of a Knight Bachelor (as shown in a painting annexed unto the said Warrant) about the neck suspended from a riband of vermilion edged with gold or gold colour and also the Badge in miniature suspended from a medal bar and taking precedence in such respect in accordance with established custom by a riband of the same design and colours (all as shown in the painting hereinbefore referred to) and that a Knight Bachelor who is armigerous may display the Badge of a Knight Bachelor pendant beneath his Shield of Arms in proper manner and with such precedence in relation to other Badges, Decorations and Insignia as may from time to time be determined.

And that Her Majesty's said Grant and Prescription be recorded in Her Majesty's College of Arms.
