##### Part I

##### *Description of Site of Existing Path*

That part of the footpath in the Parish of Shedfield in the Rural District of Droxford shown on the Definitive Map of Public Rights of Way prepared under the National Parks and Access to the Countryside Act 1949, as Footpath No. 13 between the north-east corner of Field O.S. Parcel 225 (Sheet Nos. SU5613/5713 and SU5614/5714 of 1964 Edition) approximately 170 yards west of High Street and a point approximately 181 yards west thereof where the path crosses the western boundary of the said field.

##### *Description of Site of Alternative Highway*
