(No. 1) Order 1973

Imposition of 30 m.p.h. Speed Limit

Notice is hereby given that on 30th August 1973, the Newport County Borough Council made an Order under Sections 72 (3) and 73 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The Order will come into operation on 27th September 1973. Its effect is that the lengths of road specified in the Schedule to this Notice will become subject to a speed limit of 30 m.p.h. These lengths of road are not at present subject to a speed limit. subject to a speed limit.

A copy of the Order and a map showing the affected lengths of roads may be inspected at my Office during normal office hours (except Saturdays).

If you wish to question the validity of the Order or of

any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968; or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 30th August 1973, apply to the High Court for this purpose.—Dated 10th September 1973.
