### ROAD TRAFFIC ACTS

#### NEWPORT COUNTY BOROUGH COUNCIL

*The County Borough of Newport (Restricted Roads)  
(No. 1) Order 1973*

*Imposition of 30 m.p.h. Speed Limit*

Notice is hereby given that on 30th August 1973, the Newport County Borough Council made an Order under Sections 72 (3) and 73 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The Order will come into operation on 27th September 1973. Its effect is that the lengths of road specified in the Schedule to this Notice will become subject to a speed limit of 30 m.p.h. These lengths of road are not at present subject to a speed limit.

A copy of the Order and a map showing the affected lengths of roads may be inspected at my Office during normal office hours (except Saturdays).

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968; or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 30th August 1973, apply to the High Court for this purpose.—Dated 10th September 1973.

- (i) Christchurch Road leading into Catsash Road from No. 256 Christchurch Road to the junction of Catsash Road with Christchurch Hill (northern arm).
- (ii) Christchurch Hill (north-western arm) from its junction with Christchurch Road/Catsash Road to its junction with Christchurch Hill (northern arm).

#### NORTH RIDING OF YORKSHIRE COUNTY COUNCIL

*The North Riding of Yorkshire (Spain Hill, Marske)  
(One-Way Traffic) Order, 1973*

Notice is hereby given that the North Riding of Yorkshire County Council propose to make an Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the use of Spain Hill, Marske, from its junction with Windy Hill to St. Germain's Lane, by traffic proceeding in a north to south direction.

A copy of the proposed Order, a map showing the length of road to which the Order relates and a copy of the Authority's reasons for proposing to make the Order may be inspected at the offices of the Saltburn and Marske-by-the-Sea Urban District Council, Saltburn, and at County Hall, Northallerton during normal office hours.
