The QUEEN has been pleased to order a Congé d'Elire to pass the Great Seal of the Realm empowering the Dean and Chapter of the Cathedral Church of Saint Peter in Exeter to elect a Bishop of the See of Exeter, the same being void by the resignation of the Right Reverend Father in God Doctor Robert Cecil Mortimer, late Bishop thereof; and Her Majesty has been pleased to recommend to the said Dean and Chapter the Right Reverend Eric Arthur John Mercer, now Bishop Suffragan of Birkenhead, to be by them elected Bishop of the said See of Exeter.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under section 1 (b) of the Finance Act 1973.

Viz.: The Customs Duties and Drawbacks (Reductions) (Revenue Duties) (Morocco and Tunisia) (Revocation) Order 1973.

This Order revokes the Customs Duties and Drawbacks (Reductions) (Revenue Duties) (Morocco and Tunisia) Order 1973, which would have reduced from 1st October 1973 the protective elements in and drawback rates in relation to certain revenue duties under the Agreements between the European Economic Community and Morocco and Tunisia. The Order comes into operation 30th September 1973 and has been published as Statutory Instruments 1973 No. 1636.
