Notice is hereby given that the Urban District Council of Tredegar in the Administrative County of Monmouth, the highway authority, intend to apply to the Magistrates' Court sitting at Tredegar on the 13th November 1973, at the hour of 10.30 in the forenoon, for an Order under section 108 of the Highways Act, 1959, authorising the stopping up of the part of the unclassified highway leading from Tafarnaubach to Tynwydd commencing at the eastern end of Siloam Terrace, Tafarnaubach, and proceeding in an easterly direction for a distance of 800 yards or thereabouts on the ground that such length of highway is unnecessary.
