WEST RIDING OF YORKSHIRE COUNTY COUNCIL

The County of West Riding of Yorkshire (Various Roads at Bridge Hewick, Copt Hewick and Sharow) (Weight Restriction) Order, 1973.

Notice is hereby given that the County Council of the West Riding of Yorkshire propose to make an Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968 the effect of which will be to prohibit any vehicle the unladen weight of which exceeds 3 tons from proceeding in any of the lengths of road specified in the Schedule hereto.

Exceptions will be included in the Order to enable a vehicle to proceed on the lengths of road for the conveyance of persons, goods or merchandise to and from any premises situate on or adjacent to that length of road, in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the lengths of road or the services therein, for the purposes of agriculture in connection with land adjacent to that length of road, the conveyance or haulage of timber felled upon that land, in the course of military training operations, or in pursuance of statutory duties.

Full details are contained in the draft Order which, together with a map showing the restricted roads, and a statement of reasons for proposing to make the Order may be examined during normal office hours at the offices of either (i) the County Council of the West Riding of Yorkshire (Room 87) County Hall, Wakefield or (ii) the Ripon and Pateley Bridge Rural District Council, Council Offices, Pateley Bridge.
