*The Trunk Road (Govilon, Monmouthshire) (No Right-Hand Turn) Order, 1973*

*The County of Monmouth (Govilon—Glan-y-Cafn Road) (No Right-Hand Turn) Order, 1973*

Notice is hereby given that the Secretary of State for Wales intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause any vehicle proceeding in an easterly direction in that length of the Neath—Abergavenny Trunk Road (A465), known as Heads of the Valleys Road at Govilon in the County of Monmouth to make a right-hand turn into that length of Govilon—Glan-y-Cafn Road (Route C6-8) sometimes known as Dragon Lane.

The Monmouthshire County Council intend to make a similar traffic Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause any vehicle proceeding in that length of the Govilon—Glan-y-Cafn Road (Route C6-8) sometimes known as Dragon Lane to make a right-hand turn into that length of the Neath—Abergavenny Trunk Road (A465), known as Heads of the Valleys Road at Govilon in the County of Monmouth.
