WORCESTERSHIRE COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT 1967

ROAD TRAFFIC REGULATION ACT 1967

The County of the East Riding of Yorkshire (Moor Lane, Carnaby) (Weight Restriction) Order 1973

Notice is hereby given that the County Council of the Administrative County of York, East Riding, have made the above-named Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968. The effect of the Order, which will come into operation on 1st November 1973 is to prohibit any person from driving or causing, or permitting to be driven, any vehicle the unladen weight of which exceeds 3 tons, in that length of Moor Lane, Carnaby, which extends from the Stamford Bridge—Driffild—Bridlington Road, A.166, to the railway level crossing at Carnaby Station.

Exceptions have been made in the Order in respect of public service vehicles, vehicles requiring access to adjacent property and vehicles being used in the course of military training operations.

Barnstaple Rural District Council (Hele Manor, Tawstock) Public Path Diversion Order 1973

The Beaminster Rural District Council Footpath No. 7 Chedington (Part) Public Path Diversion Order, 1973

Notice is hereby given that on 11th October 1973 the Beaminster Rural District Council confirmed the above-named Order.
