### PUBLIC HEALTH ACTS AND CLEAN AIR ACT

#### HARROW LONDON BOROUGH COUNCIL

CLEAN AIR ACTS, 1956 AND 1968

*The London Borough of Harrow Smoke Control (No. 29 Order) 1973*

Notice is hereby given that the Council of the London Borough of Harrow, in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 15th October 1973 made an Order entitled "The London Borough of Harrow Smoke Control (No. 29

Order, 1973", declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

By virtue of section 11 (4) of the principal Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels and gas and electricity. Also, in accordance with section 9 (1) of the Clean Air Act, 1968, any person who:

- (a) acquires any solid fuel, other than an authorised fuel, for use in a building in a smoke control area otherwise than in a building or fireplace exempted from the operation of section 11 of the principal Act; or
- (b) acquires any solid fuel, other than an authorised fuel, for use in a boiler or plant to which this paragraph applies in a smoke control area, not being a boiler or plant so exempted; or
- (c) sells by retail any solid fuel, other than an authorised fuel, for delivery by him or on his behalf to a building in a smoke control area or to premises in such an area in which there is a boiler or plant to which paragraph (b) above applies;

shall be liable on summary conviction to a fine not exceeding £20.

If confirmed, the Order will not come into operation before 1st November 1974 or on such later date as may be determined by the Secretary of State for the Environment.

A copy of the Order and of the map referred to therein may be inspected, free of charge, at the Department of Legal and Administrative Services, The Civic Centre, Harrow, HA1 2UH, at all reasonable times during the period of six weeks from the 2nd November 1973.

Within the said period, any person who will be affected by the Order may by notice in writing to the Secretary of State, Department of the Environment, 2 Marsham Street, London, SW1P 3EB, object to the confirmation of the Order.

#### SCHEDULE

The Area, situated in the Wealdstone North, Headstone and Wealdstone South Wards, is approximately 360 acres in extent. It is bounded to the north-east by the boundary between Wealdstone North, Headstone and Wealdstone South Wards, to the south by Elmgrove Road and Hindes Road, and to the west by Harrow View, Cunningham Park, Kingsfield Avenue, Parkside Way, Headstone Gardens and Harrow View.
