Imposition of 40 m.p.h. Speed Limit*

Notice is hereby given that on the 31st October 1973 the Bletchley Urban District Council made an Order under section 74 (1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which is that the length of road specified in the Schedule hereto shall become subject to a speed limit of 40 m.p.h.

CAMDEN LONDON BOROUGH COUNCIL

Notice is hereby given that the Council of the London Borough of Camden proposes to apply to the Greater London Council for the Camden (Parking Places) (No.) Order 197 under sections 35, 36, 37, 40 and 84D of the Road Traffic Regulation Act 1967.

2. The effect of this would be:

(1) (i) to revoke the designation of an "unlimited period parking place" in Swinton Street designated by the Parking Places (Camden) (1966) (Amendment) Order 1968

(ii) to re-designate over a lesser area an "unlimited period" parking place in Swinton Street and

(iii) to apply to the newly designated parking place the provisions of the Parking Places (Camden) Order 1966 and in particular those relating to charges and time limits and classes of vehicles for which the parking place would become available.

(2) that the restrictions imposed by the Camden (Waiting and Loading Restriction) Order 1972 would apply to the areas of highway formerly occupied by a parking place and which would not be occupied by the newly designated parking place.
