ROAD TRAFFIC REGULATION ACT 1967 The Trunk Road (Eynsham) (Bus Stops) (Clearway) Order 1973

The Secretary of State for the Environment has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, on the London—Fishguard Trunk Road (A40) in the county

of Oxford.

The effect of the Order, which comes into operation on The effect of the Order, which comes into operation on 10th November 1973, is to create a bus stop clearway on that length of the trunk road which lies in the Parish of Eynsham and extends from its junction with Witney Road (A4141) to a point 452 yards west of that junction. All vehicles except buses will be prohibited from waiting between the hours of 7 a.m. and 7 p.m. in those areas of the said trunk road contained within a Bus Stop marking which also includes a vellow line.

which also includes a yellow line.

Exceptions have been provided in the Order to enable a vehicle to wait in those areas only for the removal of any obstruction to traffic, if it is necessary for it to wait there in the exercise of statutory powers or duties, if it is required by law to stop or is obliged to wait there in order to avoid an accident, cannot proceed because of circumstances outside the driver's control or it is an emergency vehicle.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 7th Navember 1973
