BURY COUNTY BOROUGH COUNCIL

The County Borough of Bury ((Chesham) General Improvement Areas (Numbers 1 and 2)) (One Way Traffic) Order 1973

Notice is hereby given that the Council of the County Borough of Bury propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be:—

- (a) to amend the existing restrictions to permit traffic to proceed in either direction in those lengths of Dawson Street which extend
 - (i) from its junction with Chesham Road to its junction with Back Rose Bank
 - (ii) from its junction with Back Hamilton Street to its junction with Hamilton Street
- (b) to cause traffic to proceed in the streets mentioned below in the direction stated.

Street	Direction
1. The unnamed street which passes from Halstead Street to Back Dawson Street alongside the premises numbered 49 Duckworth Street.	From Halstead Street towards Back Dawson Street.
2. That length of Back Dawson Street which is situate to the north of its junction with the unnamed street which passes between the premises numbered 35 and 37 Duckworth Street.	From north to south.
3. That length of street passing at the rear of the premises numbered 2 to 48 (even numbers) inclusive Dawson Street and known for all or part of its length as Back Dawson Street which extends from its junction with the unnamed street which passes alongside the premises numbered 2 Dawson Street to its junction with the said unnamed street which passes between the premises numbered 35 and 37 Duckworth Street.	From south to north.
4. The said unnamed street which passes from Back Dawson Street to Duckworth Street between the premises numbered 35 and 37 Duckworth Street.	From Back Dawson Street towards Duckworth Street.
5. That length of Duckworth Street which extends from its junction with Back Halstead Street to its junction with Halstead Street.	From south to north.
6. That length of Back Halstead Street which extends from its junction with Back Duckworth Street to its junction with Duckworth Street.	From south east to north west.
7. Back Duckworth Street	From Back Chesham Road North towards Back Halstead Street.
8. That length of Back Chesham Road North which extends from its junction with Duckworth Street to its junction with Back Duckworth Street.	From south west to north east.
9. The said unnamed street which passes alongside the premises numbered 2 Dawson Street from Dawson Street to the street known for all or part of its length as Back Dawson Street and described in paragraph 3 above.	From Dawson Street towards the said street known for all or part of its length as Back Dawson Street.
10. That length of St. Anne's Street which extends from its junction with Hamilton Street to its junction with Back Hamilton Street.	From north to south.
11. That length of St. Anne's Street which extends from its junction with Chesham Road to its junction with the unnamed street which passes between the premises numbered 25 and 27 St. Anne's Street.	From south to north.
12. The said unnamed street which passes from St. Anne's Street to Back Hanson Street between the premises numbered 25 and 27 St. Anne's Street.	From St. Anne's Street towards Back Hanson Street.
13. That length of Back Hanson Street which extends from its junction with the said unnamed street which passes between the premises numbered 25 and 27 St. Anne's Street to its junction with Back Hamilton Street.	From south to north.
14. Hilton Street	From Chesham Road towards Ruth Street.
15. Back Hilton Street	From Ruth Street towards Chesham Road.
16. That length of Lathom Street which extends from its junction with Back Chesham Road South to its junction with Chesham Road.	From south to north.
17. That length of Brookshaw Street which extends from its junction with Brookshaw Street to its junction with Lathom Street.	From east to west.
18. Back Lathom Street	From Ruth Street towards Back Chesham Road South.
19. That length of Ruth Street which extends from its junction with Back Lathom Street to a point 68 feet south west of that junction.	From south west to north east.
20. That length of Brookshaw Street which extends from its junction with Chesham Road to its junction with Brook Street.	From Chesham Road towards Brook Street.
21. That length of Brook Street which extends from its junction with Brookshaw Street to its junction with the unnamed street which passes between the premises numbered 138 and 140 Brook Street.	From north west to south east.
22. The said unnamed street which passes from Brook Street to Back Brook Street North between the premises numbered 138 and 140 Brook Street.	From Brook Street towards Back Brook Street North.
23. That length of Back Brook Street North which extends from its junction with the said unnamed street which passes between the premises numbered 138 and 140 Brook Street to its junction with Canon Street.	From north west to south east.
