The inquiry in connection with the Order will hear representations from persons interested in the land comprised in the Order, and at the Inspector's discretion, hear representations from any other persons who may desire to appear and be heard. A copy of the Compulsory Purchase Order and of the Map referred to therein have been deposited and may be seen at all reasonable hours at the Department of the Environment, Room 1/39, St. Christopher House, Southwark Street, London S.E.I., and at the Town Hall, Treaty Road, Hounslow, Middlesex and the Chiswick District Library, Dukes Avenue, Chiswick W.4. The said Compulsory Purchase Order has been made by the Council of the London Borough of Hounslow under the Highways Act 1959 and the Acquisition of Land (Authorisation Procedure) Act 1946 and if confirmed by the Secretary of State will authorise the council to acquire compulsorily the land described therein for the purpose of constructing a new highway to service a proposed housing redevelopment at Fishers Lane (which construction shall incorporate the present Belmont Place) which is to be a highway maintainable at public expense. B—An application by the Hounslow London Borough Council for planning permission to develop part of Chiswick Common Road for public open space purposes. (Reference LGP/5019/223/50.)
