## WAGES COUNCIL ACT 1959

### LICENSED NON-RESIDENTIAL ESTABLISHMENT WAGES COUNCIL

The Licensed Non-residential Establishment Wages Council hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) varying the provisions relating to statutory minimum remuneration and holidays and holiday remuneration set out in the Wages Regulation (Licensed Non-residential Establishment) Order 1972 (Order L.N.R.(91)) as amended by the Wages Regulation (Licensed Non-residential Establishment) (Amendment) Order 1972 (Order L.N.R.(95)); (2) the revocation of Order L.N.R. (91) and Order L.N.R. (95); (3) varying the provisions relating to statutory remuneration and holidays and holiday remuneration set out in the Wages Regulation (Licensed Non-residential Establishment) (Managers and Club Stewards) Order 1972 (Order L.N.R. (92)) as amended by the Wages Regulation (Licensed Non-residential Establishment) (Managers and Club Stewards) (amendment) Order 1972 (order L.N.R. (96)); and (4) the revocation of Order L.N.R. (92) and Order L.N.R. (96).

Particulars of the proposals, which have been approved by the Pay Board, are contained in the Wages Council's Notices L.N.R. (99) and L.N.R. (100) which may be obtained on application to the Secretary of the Wages Council at the address given below. The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 21 days from 16th November 1973. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notices of Proposals L.N.R. (99) and L.N.R. (100).

## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACT 1971
