WATER RESOURCES ACT, 1963

NOTICE OF APPLICATION FOR A LICENCE TO ABSTRACT WATER

Notice is hereby given that the Wye River Authority have, in accordance with the Water Resources Act 1963 and the Water Resources (Licences) Regulations 1965, drafted a licence to abstract water from an unnamed tributary of the River Wye at Cwm-Bach near Glasbury at National Grid Reference S.O.1674 3963.

The object of the abstraction is to supply a fish hatchery. The maximum daily rate of abstraction proposed is 100,000 gallons and the maximum annual abstraction proposed is 30,000,000 gallons. Further details of the abstraction are that the water will be returned to the stream at National Grid Reference S.O.1674 3955, 300 feet below the point of abstraction.

A copy of the draft licence and of the relevant plan may be inspected free of charge at the offices of the Authority at 4 St. John Street, Hereford, during normal office hours during the period beginning on 30th November 1973 and ending on 28th December 1973.

Any person who wishes to make representations about the draft licence should do so in writing to the Clerk of the Wye River Authority at 4 St. John Street, Hereford, HR1 2NE, before the end of the said period.

After the expiry of the period set for the inspection of the documents and the submission of representations the Authority will be entitled to pass a resolution by virtue of which a licence authorising the proposals shall be deemed to be granted, unless the Secretary of State for the Environment either in consequence of any representations made with respect to the proposals or otherwise, requires an application for a licence to be made to him.
