# **ROAD TRAFFIC REGULATION ACT 1967** The Trunk Road (Orchard Street, Oughtibridge)

(Prohibition of Waiting) Order 1973 The Secretary of State for the Environment has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, on the Liverpool-Warrington-Stockport-Sheffield-Lincoln-Skegness Trunk Road (A616).

The effect of the Order, which comes into operation on 1st December 1973, is to prohibit waiting at all times on the south-west side of that length of the trunk road known as Orchard Street, Oughtibridge, in the Rural District of Wortley in the West Riding of Yorkshire, which extends from its invition with Bridger Hill to a point extends from its junction with Bridge Hill to a point 108 yards north-west of that junction.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 27th November 1973 apply to the High Court for the suspen-sion or quashing of the Order or of any provision contained therein.

## **ROAD TRAFFIC REGULATION ACT 1967**

The Trunk Road (Prohibition of Waiting) (Clearways)

The Secretary of State for the Environment proposes to make an Order under sections 1 (1), (2) and (3) and (6) and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be:

- (1) to prohibit waiting on any of those main carriageways forming part of the London—Cambridge—King's Lynn Trunk Road (A.10) which are specified in the Schedule hereto; and
- (2) to prohibit waiting by any vehicle for the purpose of trading, unless the goods are immediately delivered at or taken into premises adjacent to the vehicle, on any verge or lay-by adjacent to the said main carriageway.
- The prohibition imposed by the Order will not apply:
- (a) to a vehicle waiting upon the direction or with the permission of a police constable in uniform; (b) so as to prevent a vehicle from being used in con-
- (c) so as to prevent a venter in both both both of any obstruction or demolition, the removal of any obstruction to traffic, the maintenance of the road or of any of the services therein;
  (c) to a vehicle being used for fire brigade, ambulance or police purposes;
- (d) to a vehicle being used for the purpose of delivery or collecting postal packets;
  (e) to a vehicle being used by or on behalf of a local
- authority for the purpose of collecting household refuse or clearing cesspools;
