ROAD TRAFFIC REGULATION ACT, 1967

The Trunk Road (Chester Road, Stretford) (Prohibition of Right-Hand Turn) Order, 1973

The Secretary of State for the Environment has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, on the Swansea-Manchester trunk road.

The effect of the Order, which comes into operation on 3rd December 1973, is to revoke the Trunk Road (Chester Road, Stretford) (Prohibition of Right-Hand Turn) Order 1967 (which prohibited right-hand turns into King Street in the Borough of Stretford) and to prohibit any vehicle proceeding in the Swansea-Manchester trunk road known as Chester Road in the Borough of Stretford from making a right-hand turn into Kingsway in the said Borough. Exceptions have been provided in the Order to enable

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Any person who desires to question the validity of, or of any provision contained in, the Order on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 27th November 1973, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The Trunk Road (Knutsford Road and London Road, Church Hulme) (Prohibition of Waiting) Order, 1973
