The QUEEN has been pleased to approve the award of the Colonial Police Medal for Gallantry to Detective Chief Inspector Clive Edward DONALD and Detective Sergeant Larry Eugene Smith of the Bermuda Police Force.

On the evening of 18th October 1973, Detective Chief Inspector Donald and Detective Sergeant Smith were keeping observation from some bushes with a view to apprehending Erskine Durrant "Buck" Burrows, who was wanted in connection with two major armed robberies, and also for other firearms offences. It was known to both the Officers that Burrows was carrying a loaded sawn-off pump action shotgun and a loaded hand gun and that the shotgun was carried in a ready position by a sling.

When Burrows approached this hiding place on an auxiliary cycle both Officers jumped him and brought him

to the ground where, with the assistance of other Officers, they were able to overpower him, although he was in possession of the loaded weapons.
