*The Orrell Urban District Council (Footpath No. 7)  
Public Footpath Diversion Order, 1973*

Notice is hereby given that on 20th November 1973, the Orrell Urban District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert part of the public right of way from a point approximately 130 metres north of Spring Road, Orrell, for a distance of 65 metres in a westerly direction, then for a distance of 60 metres in a southerly direction, then for a distance of 50 metres in a south-westerly direction crossing a culverted stream indicated at point E on the map accompanying the Order, and then for a distance of 50 metres in a southerly direction to join Spring Road.

A copy of the Order and map contained therein is available for inspection free of charge at the Council Offices, Orrell Road, Orrell, between the hours of 9 a.m. and 12 noon, and 1 p.m. and 5 p.m. Mondays to Fridays inclusive.

This Order becomes operative as from 7th December 1973, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with, in relation to the confirmation of the Order, he may, under section 178 of the Town and Country Planning Act 1962, within 6 weeks from 7th December 1973, make application for the purpose to the High Court.

Notice is hereby given that the above-named Orders made on the 3rd December 1973, are about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as unopposed Orders, by the Cosford Rural District Council.

The effect of the respective Orders, if confirmed without modifications, will be as follows:

*Thorpe Morieux Footpath No. 1*

To extinguish the public right of way, being footpath No. 1 running from the Lavenham Road, Thorpe Morieux east of Mount Farm in a northerly and north-easterly direction for a distance of approximately 340 metres to a point on the Malting Farm Road south of Underwoods (or Thorpe) Farm.

*Thorpe Morieux Footpath No. 3*

To divert the public right of way, being footpath No. 3, running from Grange Road, Thorpe Morieux north-west of Birds Farm in a north-easterly direction for approximately 330 metres and then north for approximately 202 metres to School Lane at the bend of the road south of the old school; to a line running from the junction of School Lane with Grange Road in a north-easterly and east-north-easterly direction along School Lane for a total distance of approximately 320 metres to the bend in the road south of the old school.

*Thorpe Morieux Footpath No. 11*

To divert that part of the public right of way being footpath No. 11 running from its point of junction with

footpath No. 12 approximately 200 metres north-east of Water Hall (point A) in an easterly and north-easterly direction for approximately 820 metres to Bury Road; to a line running from the junction at point A in an easterly direction for a distance of approximately 650 metres to Bury Road, Thorpe Morieux.

*Thorpe Morieux Footpath No. 14*

To divert that part of the public right of way, being footpath No. 14 starting from its junction with path No. 16 approximately 90 metres south of Valley Farm and running north-west for approximately 100 metres and north-north-west for approximately 200 metres to its junction with path No. 15; to a line starting with its junction with path No. 16 approximately 20 metres south-east of Valley Farm buildings and running north for a distance of approximately 32 metres to a point on the north-west of the said buildings along the north side of the buildings and then generally north-west for a distance of approximately 220 metres to its junction with path No. 15.

Copies of each of the Orders and of the maps contained in them have been deposited at and may be inspected free of charge at the Council Offices, 32 High Street, Hadleigh, Ipswich, IP7 5AW between 9 a.m. and 5 p.m. on Mondays to Fridays.

Any objection or representation concerning any of the Orders may be sent in writing to the Clerk of the Cosford Rural District Council, Council Offices, 32 High Street, Hadleigh, Ipswich, IP7 5AW before the 16th January 1974.

If in respect of any such Order no representations or objections are duly made, or if any so made are withdrawn, the Cosford Rural District Council may instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

Notice is hereby given that the above-named Orders made on the 3rd December 1973 are about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as unopposed Orders, by the Cosford Rural District Council.

The effect of the respective Orders, if confirmed without modifications, will be as follows:

*Preston St. Mary Footpath No. 4*

To extinguish the public right of way, being path No. 4, from a point on the Brettenham Road approximately 100 metres south of Mortimers Farm buildings running in an easterly direction for approximately 560 metres to the point where it joins bridlepath No. 21 south-west of Rushbrook Farm, Preston St. Mary.

*Preston St. Mary Footpath No. 5*

To extinguish the public right of way, being path No. 5, from a point on the Brettenham Road approximately 120 metres east of its junction with the Thorpe Morieux Road running in a south-easterly direction to Charity Farm and then in a south-westerly direction to Charity Farm Road, Preston St. Mary.

*Preston St. Mary Footpath No. 6*

To divert that part of footpath No. 6 from point A approximately 235 metres north of Rookwood Lane at its junction with footpath No. 7 running in a north-north-westerly direction for a distance of approximately 180 metres to point B; to a line from point B east for approximately 90 metres to join path No. 7 at point C adjacent to Down Hall Farm buildings, Preston St. Mary.
