The County of Derby (Public Footpath No. 81—Ripley Urban District)

Public Path Diversion Order 1973

Notice is hereby given that on the 29th day of November 1973, the Derbyshire County Council confirmed the above Order.

The effect of the Order, as confirmed, is to divert part of Footpath No. 81 commencing at point A on Bridle Lane and proceeding in a westerly direction alongside the Cromford Canal for a distance of 550 yards or thereabouts to a point B at Starvehimvalley Bridge, to a new line commencing at point C on Bridle Lane proceeding in a westerly direction alongside the southern embankment of the disused railway line for a distance of 600 yards or thereabout to point D and thence continuing in a north-easterly direction for 80 yards or thereabouts to the aforesaid point B.

A copy of the confirmed Order and the map contained in it has been deposited and may be inspected free of charge at the County Offices, Matlock, and at the offices of the Ripley Urban District Council, Town Hall, Ripley, between the hours of 9 a.m. to 1 p.m. and 2 p.m. to 5 p.m., Mondays to Fridays.

TOWN AND COUNTRY PLANNING ACT, 1971, SECTION 210
The County of Derby (Public Footpath No. 3—Parish of Smalley) Public Path Diversion Order, 1973

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 29th November 1973, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Derbyshire County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert part of Footpath No. 3 in the parish of Smalley, rural district of Belper, commencing at point B on the boundary between Ordnance Parcels 2768 and 2355 and proceeding in a northerly direction for a distance of 245 yards or thereabouts to Point A which is at the junction of Footpaths 1, 2 and 3, to a new line commencing at the aforesaid Point B and proceeding westwards to Point C, thence northwards to Point D, through Ordnance Parcel 0660, a distance of 310 yards or thereabouts. (From Point D, the existing footpath network can be utilised.)

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the County Offices, Matlock, Room 109, and at the offices of the Belper Rural District Council, Field Head House, Chesterfield Road, Belper, between the hours of 9 a.m. to 1 p.m. and 2 p.m. to 5 p.m. Monday to Friday.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the Council, County Offices, Matlock, not later than Monday 31st December 1973, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Derbyshire County Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
