ROAD TRAFFIC REGULATION ACT 1967

The Trunk Road (Ingatestone) (One Way Traffic) Order 1974

The Secretary of State for the Environment proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 on the London—Great Yarmouth Trunk Road (A.12) in the County of Essex.

The effect of the Order will be to revoke the One Way Traffic Order in operation before the re-alignment of roads at the south-western end of the Ingatestone By-Pass, except for a short length which now forms part of the slip road for southbound traffic leaving the By-Pass. Traffic will proceed only from north-west to south-east in this length of the trunk road.

A copy of the Order, a copy of the Orders to be revoked, together with a plan illustrating the proposal and a Statement of Reasons, may be inspected during office hours at the offices of the Essex County Council at County Hall, Chelmsford.
