(a) between the hours of 7 a.m. and 7 p.m. Mondays to Saturdays inclusive on the following lengths of road: *Martin Hardie Way*

North side, from its junction with Higham Lane to the east side of Constable Road (excluding the lay-by);

South side, from its junction with Higham Lane to the party wall of Nos. 23-25 Martin Hardie Way (excluding the lay-by);

Higham Lane, west side, between points 32 metres south and 36 metres north of the centre of Martin Hardie Way.

Dodd Road, both sides, for a distance of 15 metres from its junction with Martin Hardie Way.

(b) at any time:

(i) on both sides of Avebury Avenue from a point 15 metres from its junction with High Street to a point 6 metres west of River Lawn Road;

(ii) on both sides of High Street from a point opposite the boundary of Nos. 139-141 High Street to a point 25 metres north of Church Lane,

(iii) Lyons Crescent

North and west sides, from its junction with High Street to its junction with East Street. South side, from its junction with High Street for

South side, from its junction with High Street for a distance of 150 feet.

East side, from its junction with East Sreet for a distance of 45 feet.

East and south sides, from the southern boundary of No. 35 Lyons Crescent to the western boundary of the premises of Mortley Sprague and Company Limited.

The Orders will come into force on the 31st December 1973.

Copies of the Orders, together with maps showing the restricted areas may be examined at the offices of the Clerk of the Council, Tonbridge Castle, Tonbridge, during the hours of 9 a.m. to 1 p.m. and 2.15 p.m. to 5 p.m. Mondays to Fridays inclusive.

Any person who desires to question the validity of the Orders or of any provision contained in the Orders on the ground that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Orders may, within six weeks from the 11th December 1973, apply to the High Court for this purpose.

WATFORD BOROUGH COUNCIL

The Borough of Watford (Rosslyn Road) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1974.

Notice is hereby given that the Watford Borough Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting atall times on the north east side of Rosslyn Road from its junction with Upton Road in a north westerly direction for 100 metres. The usual exemptions will apply. Waiting will also be prohibited (except for coaches) on the north east side of Rosslyn Road between a point 16 metres south east of the junction with Halsey Road and a point 100 metres north west of the junction with Upton Road.
