The Trunk Road (Pontardulais, Glamorgan) (Prohibition of Waiting) Order 1974

Notice is hereby given that the Secretary of State intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting at any time in that length of the London-Fishguard Trunk Road A.48, known in part as Bolgoed Road and in part as St. Teilo Street, at Pontardulais in the county of Glamorgan, which extends from a point 75 yards south-east of its junction with Pentre Road in a

north-westerly direction for a distance of 165 yards. Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local

or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties. A copy of the proposed Order, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours at the Pontardulais Public Library, St. Michael's Avenue, Pontardulais. Objections to the proposed Order should be sent to the Secretary of State, Welsh Office, Roads Division (Y Swyddfa Gymreig, Adran Ffyrdd), 139 Newport Road, Cardiff, CF2 1YU, by 1st February 1974 quoting the reference number R 15/434/5.
