TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday the 8th February 1974, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £60,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the Tenderer on any business day from Monday the 11th February 1974, to Friday the 15th February 1974, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Town and Country Planning Act 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of those lengths of highway described in the Schedule below to enable re-development to be carried out in accordance with a planning permission which has been granted under Part III of that Act.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained

therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 5th February 1974 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

(All distances are approximate)

The highways to be stopped up are in the County Borough of Cardiff. They are shown by zebra hatching on the deposited plan and are:

- (1) that length of Picton Place which extends from a point 8 yards south-east of its junction with Wellington Street in a south-easterly direction for a distance of 26 yards; and
- (2) that length of Albert Lane which extends from its junction with Phillip Street in a south-easterly direction to its junction with Wellington Street, a distance of 65 yards.

The Trunk Road (North Road, Merthyr Road, Caerphilly Road, Cardiff) (One-Way Traffic) Order 1974

Notice is hereby given that the Secretary of State intends to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that:

- (i) no person shall cause any vehicle to proceed in a direction other than from north to south in that length of the Cardiff—Llangurig Trunk Road (A.470) known in part as Caerphilly Road and in part as North Road, in the County Borough of Cardiff, which extends from its junction with St. George's Road in a southerly direction for a distance of 132 yards;
- (ii) no person shall cause any vehicle to proceed in a direction other than from south-east to north-west in that length of the Cardiff—Llangurig Trunk Road (A.470), known in part as North Road and in part as Merthyr Road, in the County Borough of Cardiff, which extends from a point 18 yards north-west of its junction with Llwynderw Road in a south-easterly direction for a distance of 135 yards.

This proposal replaces that set out in the Trunk Road (North Road, Merthyr Road, Cardiff) (One-Way Traffic) Order 1974, which was advertised on 3rd January 1974.
