

STOCKPORT COUNTY BOROUGH COUNCIL

The County Borough of Stockport (Various Roads) (Prohibition and Restriction of Waiting) Order 1974 (No. 198)

Notice is hereby given that the Stockport County Borough Council has made an Order under the provisions of section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit or restrict the waiting of vehicles, (a) at any time between the hours of 8 a.m. and 6.30 p.m., Monday to Saturday inclusive in the side of road, lengths of road, and sides of lengths of road specified in Schedule 1 to this notice at any time on the sides of the length of roads specified in Schedule 2 to this notice.

Exceptions are provided in the proposed Order for passengers to board or alight, goods to be loaded or unloaded and works to be carried out on the road.

A copy of the Order and maps showing the roads to which the Order relates may be inspected during normal office hours at Room 44, Town Hall, Stockport.

Any person who desires to question the validity of the Order which will become operative on 11th February 1974, or any provision contained in the Order on the ground that it is not within the powers of the relevant section of the Act or on the grounds that any requirement of that section or of sections 84A, 84B or 84C of the Act or any regulation made under the said section 84C has not been complied with in relation to the Order may within 6 weeks of 5th February 1974, make application for the purpose to the High Court.

SCHEDULE 1

Length of a side of road in the County Borough of Stockport

Junction Road, both sides, between its junction with Longshut Lane and the northern boundary of Thomas Street.

SCHEDULE 2

Banbury Street, west side, from its junction with Garnett Street to its junction with Covent Garden.

Covent Garden, north side, between the junction with Banbury Street and the commencement of the turning area. (481)

The County Borough of Stockport (Wellington Road South and Wellington Street) (Prohibition of Right-Hand Turn) Order 1974 (No. 201)

Notice is hereby given that the Stockport County Borough Council has made an Order under the provisions of section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit vehicles proceeding in Wellington Road South making a right-hand turn into Wellington Street.

STOCKPORT COUNTY BOROUGH COUNCIL

The County Borough of Stockport (Broadstone Hall Road South) (Weight Restriction) Order 1973 (No. 199)

Notice is hereby given that the Stockport County Borough Council has made an Order under the provisions of the

Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit the driving of any motor vehicle, the unladen weight of which exceeds 1½ tons, along the length of road specified in the Schedule hereto. Exceptions will be provided for vehicles used for (a) the conveyance of persons, goods or merchandise; (b) the collection of refuse; (c) fire-fighting; and (d) carrying out certain works on the roads.

STOKE-ON-TRENT CITY COUNCIL

City of Stoke-on-Trent Traffic Regulation (No. 5) Order, 1974

Notice is hereby given that the Stoke-on-Trent City Council propose to make an Order under section 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

The effect of the Order will be to prohibit the driving of vehicles in the un-named passage connecting Warrington Road and Egerton Street, Hanley from a point 22 yards (20 metres) from its junction with Warrington Road otherwise than in a south-westerly direction.

Full details of the proposal contained in a Draft Order which together with a map showing the street concerned and a statement of the Council's reasons for proposing to make the Order may be examined at my office during ordinary office hours.

If you wish to object to the proposed Order you should send your objection together with the grounds thereof in writing to me by 1st March 1974.
