*The Walton and Weybridge Urban District (Various Streets)
(Prohibition of Waiting) Order No. 1, 1973*

Notice is hereby given that on 29th January 1974, the Walton and Weybridge Urban District Council made the above-named Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

The Order, which restricts the waiting of vehicles in the lengths of road specified in the Schedule to this notice will come into operation on the 11th February 1974.

A copy of the Order and map is available for inspection at the Town Hall, New Zealand Avenue, Walton-on-Thames, between the hours of 9 a.m. and 1 p.m. and 2 p.m. and 5 p.m., Mondays to Fridays.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 7th February 1974, apply to the High Court for this purpose.

NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1971—SECTION 210

*The Driffield Rural District (Hutton Cranswick) Public
Path Diversion Order 1974*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 4th February 1974 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Driffield Rural District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running in an east-south-easterly and south-south-easterly direction in field O.S. 218, east of Southgate, Cranswick, to a line running mainly north and east of such public right of way.

A copy of the Order and the map contained in it has been deposited at the Council Offices, "West Garth", Driffield, and may be inspected free of charge between 9 a.m. and 5 p.m. on weekdays (Monday to Friday).

Any representation or objection with respect to the Order may be sent in writing to the Driffield Rural District Council, Council Offices, "West Garth", Driffield, not later than 11th March 1974 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Driffield Rural District Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.
