Notice is hereby given that the Flintshire County Council propose to make an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the waiting of vehicles:

(a) At any time in the lengths or on the sides of lengths of road specified in Part I of the Schedule hereto.
(b) Between the hours of 7 a.m. and 7 p.m. on the sides of lengths of road specified in Part II of the Schedule hereto.

(c) For a longer period than 30 minutes in any period of 1 hour on either of the sides of lengths of road specified in Part III of the Schedule hereto.

The County of Flint (Various Streets, Rhuddlan) (Prohibition and Restriction of Waiting) Order 1968, will be revoked.

Exceptions will be provided in the proposed Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like.

SCHEDULE

Lengths and Sides of Lengths of Road at Rhuddlan in the Rural District of St. Asaph in the County of Flint

PART I

Abergele Road, High Street and Rhyl Road (A.525)

North-westerly side:

(a) from a point 20 yards south-west of its junction with Tan-yr-Eglwys Road to a point 20 yards northeast of that junction;

(b) from a point 20 yards south-west of its junction with Church Road to a point 20 yards north-east of that junction;

(c) from a point 20 yards south-west of its junction with Gwindy Street to a point 20 yards north-east of that junction;

(d) from a point 20 yards south-west of its junction with Coetiau Postol Road to a point 20 yards northeast of that junction.

South-easterly side:

(a) from a point 20 yards south-west of its junction with Castle Street to a point 20 yards north-east of that junction;

(b) from a point 20 yards south-west of its junction with Parliament Street to a point 20 yards north-east of that junction;

(c) from a point 20 yards south-west of its junction with Princes Road to a point 20 yards north-east of that junction.

Tan-yr-Eglwys Road. Both sides; from its junction with the A.525 for a distance of 20 yards in a north-westerly direction.

Church Street. Both sides; from its junction with the A.525 for a distance of 20 yards in a north-westerly

Gwindy Street. Both sides; from its junction with the A.525 for a distance of 20 yards in a north-westerly direction.

Coetiau Postol Road. Both sides; from its junction with the A.525 for a distance of 20 yards in a northerly direction.

Princes Road. Both sides; from its junction with the A.525 for a distance of 20 yards in a south-easterly direction.

Parliament Street. Both sides; from its junction with the A.525 for a distance of 20 yards in a south-easterly direction.

Castle Street. Both sides; from its junction with the A.525 for a distance of 20 yards in a south-easterly direction.
