*Extension of 30 m.p.h. Speed Limit—C.86 Rowley Lane, Borehamwood*

Notice is hereby given that the Hertfordshire County Council made an Order under section 72 (3) and 73 (1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

When this Order comes into effect the length of road specified in the Schedule to this notice will become subject to a speed limit of 30 m.p.h.

The Order together with a map showing the length of road concerned may be inspected at the offices of the Elstree Rural District Council, Council Offices, Shenley Road, Borehamwood, and at Room 122, County Hall, Hertford, during normal office hours.

This Order came into operation on the 21st January 1974.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may, within 6 weeks apply to the High Court for this purpose.

*The County of Hertford (The Crescent, Abbots Langley) (Restriction of Waiting) Order, 1973*

Notice is hereby given that the Hertfordshire County Council have made an Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to restrict the waiting of vehicles in Abbots Langley as follows:

*Waiting allowed for a period of one hour in any two hours 8 a.m. to 6.30 a.m. Monday to Saturday inclusive*

The Crescent (northeast area), south-west side, from a point 20 yards south-east of its junction with High Street, south-eastwards for 32 yards.

Exceptions will permit waiting for the purposes of:

- (a) picking up and setting down passengers,
- (b) loading and unloading goods,
- (c) the maintenance of roads, and
- (d) the supply of gas, electricity and water,
- (e) disabled drivers will be exempt from the limited waiting restrictions as indicated in item 1 above.

The County of Hertford (Various Roads, Abbots Langley) (Prohibition and Restriction of Waiting) Order 1973 will be amended.

A copy of the Order and a plan showing the roads to which the Order relates may be inspected at the offices of the Watford Rural District Council, Council Offices, Wynyard House, Langley Road, Watford and at Room 122, County Hall, Hertford.

*Imposition of 30 m.p.h. Speed Limit—C.58 Fellows Lane, Colney Heath*

*The County of Hertford (High Street, Baldock) (Prohibition of Waiting) Order, 1973*

Notice is hereby given that the Hertfordshire County Council have made an Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the waiting of vehicles at all times in the following length of road at Baldock:

*High Street:*

Western side, from its junction with Mansfield, southwards for a distance of 1,075 feet to a point opposite the Astoria Bingo Hall. (The lay-by outside the Police Station will be excluded.)

Eastern side, from its junction with Pinnocks Land to its junction with South Road.

Exemptions are provided in the Order for:

1. Picking up and setting down passengers;
2. Loading or unloading of goods, and where necessary in connection with;
3. The maintenance of the roads;
4. The supply of gas, electricity and water.

A copy of the Order and a plan showing the roads to which the Order relates may be inspected at Baldock Urban District Council, Council Offices, Baldock and at Room 122, County Hall, Hertford.
