The purpose of the Order is to prohibit vehicles, other than buses from waiting between 7 a.m. and 7 p.m. on any day at any bus stop in the length of road specified below

where the carriageway at that stop is marked (a) as a bus stop, and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings").

Although the Order includes every bus stop in the length of road specified below, it should be noted that the provisions of the Order which prohibit waiting only apply to those bus stops which the Secretary of State has marked with the

authorised markings.

While the Order remains in force it enables the Secretary of State at any time to lay or remove the authorised markings at or from any bus stop in the specified length of road or to adjust the position in that length of road of the authorised markings, as traffic conditions may require.

Other vehicles are permitted to wait at the bus stops with

authorised marking where necessary for:

1. The removal of an obstruction to traffic.

2. The maintenance of the road, and in exercise of statutory powers with permission of the local authority; and

3. Reasons of emergency.
