KENT COUNTY COUNCIL

The County Council of Kent (Various Roads, Paddock Wood) (Prohibition of Waiting) Order

Notice is hereby given that the Kent County Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, which will affect the existing waiting restrictions at Paddock Wood as follows:

- (a) the existing restrictions in the short lengths of Church Road and Station Road adjoining the junction with Commercial Road will be replaced by a prohibition of waiting at all times; and
- (b) waiting will be prohibited between 7.30 a.m. and 6.30 p.m. on Mondays to Saturdays in Church Road from 33 yards east of its junction with Commercial Road (the limit of the existing restrictions) to its junction with St. Andrews Road, a distance of 367 yards.

Exceptions will be provided in the Order to enable a vehicle to wait with police permission or for passengers to board or alight, for the loading or unloading of goods, for enabling works to be carried out in or adjacent to the road and for disabled persons.
