SCHEDULE

Description of highways to be stopped up. (The distances are approximate.) The highways to be stopped up are in the Borough of Port Talbot in the County of Glamorgan. They are shown by zebra hatchings on the deposited plan and are:

- 1. that length of road known as Church Street, which extends from the north-east side of the main railway line to the south-west side of its junction with Albert Terrace, a distance of 113 yards;
- that length of road, known as Church Place, which extends from its junction with Church Street to its junction with Water Street, a distance of 37 yards;
- 3. that length of road, known as Gethin Street, which extends from its junction with Water Street to its end at the river bank, a distance of 67 yards;
- 4. that length of road, known as Albert Terrace, which extends from its junction with Church Street in a north-westerly direction to No. 3 Albert Terrace, a distance of 32 yards;
- (a) that length of road, known as Green Park Street, which extends from No. 2 Green Park Street to its junction with Water Street, a distance of 13 yards;
 - (b) that length of road, known as Green Park Street, which extends from its junction with Pritchard Street in a northerly direction for a distance of 18 yards;
- 6. that length of road known as Pritchard Street, which extends from its north-eastern terminal point in a south-westerly direction for a distance of 7 yards;
- 7. (a) that length of road, known as Water Street, which extends from a point outside No. 70 Water Street to a point outside the Baptist Chapel, a distance of 59 yards;
 - (b) that length of road, known as Water Street, which extends from the south-west side of the Railway Bridge to a point 28 yards north-east of that Railway Bridge. a distance of 38 yards;
