

The principal changes are as follows:

- (i) instead of vehicles being prohibited from waiting between 7 a.m. to 7 p.m. on the south side of Glynne Way from a point 40 yards south-east of its junction with Rectory Lane to a point 140 yards south-east of that junction, vehicles will be allowed to wait during the said hours, for a maximum period of 15 minutes in any one hour.
- (ii) a loading and unloading prohibition with an exception for vehicles used for postal purposes will apply to the north side of the length of Glynne Way specified in (i) above, during the hours of 7 a.m. and 10 a.m. and 4 p.m. and 6 p.m.

Exceptions have been provided in the Order to allow invalid vehicles and vehicles bearing a disabled person's badge to wait for so long as may be necessary on the side of road specified in (i) above.

A copy of the proposed Order, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours, at the offices of Hawarden Rural District Council, Hawarden, Chester.

#### ROAD TRAFFIC REGULATION ACT 1967

##### *Imposition of 30 m.p.h. Speed Limit*

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 72 (3) and 73 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit the driving of motor vehicles at a speed exceeding 30 m.p.h. in the length of road specified in the Schedule below.

If you wish to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks of the 21st February 1974 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

#### SCHEDULE

That length of the Swansea—Manchester Trunk Road, A.483, known as Newbridge Road at Newbridge in the county of Denbigh, which extends from the north-westerly abutment of the Dee River Bridge to the south-easterly abutment of the said bridge, a distance of approximately 57 yards.
