#### KENT COUNTY COUNCIL

*The County Council of Kent (Langton Road and Stonewall Park Road, Speldhurst) (Prohibition of Waiting) Order*

Notice is hereby given that the Kent County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, to prohibit the waiting of vehicles between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive at Speldhurst:

- (a) in Langton Road, A.264, (i) north side between points 15 yards east and 17 yards west of the centre of Stonewall Park Road, and (ii) south side between points 94 yards east and 46 yards west of the centre of that junction;

*The Urban District of Kingswood (Beaconlea, Kingswood) (Restriction of Waiting) (Variation) Order, 1972*

#### LANCASHIRE COUNTY COUNCIL

*The Lancashire County Council (Colne Lane, Colne) (Restriction of Waiting) Order 1974*

Notice is hereby given that the Lancashire County Council have made an Order under section 1 (1), (2) and (3) of the

Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 the effect of which is to:

- (a) restrict the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on any day except a Sunday to 30 minutes with return prohibited within 30 minutes on the following length of road in the Municipal Borough of Colne:

The west side of Colne Lane from its junction with Church Street A.56 to its junction with Craddock Road.

- (b) prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on any day except a Sunday on the following lengths of road in the Municipal Borough of Colne:

The east side of Colne Lane from its junction with Church Street A.56 to its junction with Craddock Road.

The Order contains exemptions to allow vehicles to wait for as long as may be necessary to enable goods to be loaded or unloaded or used in connection with any building operation or demolition and the maintenance of essential services or to enable persons to board or alight therefrom.

Any person wishing to question the validity of the Order may within six weeks from the 26th February 1974, apply to the High Court for the purposes.

*The Lancashire County Council (Footpaths at Aughton and Banks West Lancashire Rural District) (Prohibition of Cycling) Order 1974.*

*The Lancashire County Council (Bold Lane Aughton, West Lancashire Rural District) (Prohibition and Restriction of Waiting) Order 1974.*

Notice is hereby given that the Lancashire County Council have made the above Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, the effect of which is to:
