#### MISUSE OF DRUGS ACT 1971, SECTION 12 (2)

Direction Prohibiting Exercise of Powers in Relation to Controlled Drugs Sukumar Sarkar

In accordance with section 12 (2) of the Misuse of Drugs Act, 1971, notice is hereby given that the Secretary of State gave the following direction which was served and thereby came into effect on 5th March 1974:
