

In the High Court of Justice (Chancery Division).—  
No. 002155 of 1973

In the matter of D. & J. PARKER (SPRAYING & DECORATING) LIMITED and in the matter of the Companies Act 1948.

Notice is hereby given that by an order made on Monday the 21st January 1974 upon the petition of the above named D. & J. Parker (Spraying & Decorating) Limited (hereinafter called the company) and of Desmond Charles Laurence Parker of Joyce Landsdowne Road Alton in the County of Hants a member of the company on the 3rd December 1973 preferred unto this Court

And upon hearing counsel for the petitioners and for the Registrar of Companies (the respondent)

And upon reading the said petition (as amended) the affidavit of Desmond Charles Laurence Parker filed the 11th December 1973 the affidavit of Mark Markanday filed the 20th December 1973 and the exhibits in the said affidavits respectively referred to

And the petitioners by their counsel undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by sections 124 and 126 of the above-mentioned Act, a copy of the annual return of the company for each of the years 1968 to 1972 inclusive together with the documents annexed thereto as required by section 127 of the said Act, to give to the Registrar of Companies as required by section 107 of the said Act notice of any change in the situation of the registered office of the company, to send to the Registrar of Companies as required by section 200 of the said Act a notification of any change among the directors of the company or in its secretary or in any of the particulars contained in its register of directors and secretaries specifying the date of the change and to deliver to the Registrar of Companies as required by section 52 of the said Act a return of allotments

This Court doth order that the name of the above named D. & J. Parker (Spraying & Decorating) Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said D. & J. Parker (Spraying & Decorating) Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this order in his official name in the *London Gazette*

And it is ordered that the petitioners the said D. & J. Parker (Spraying & Decorating) Limited and Desmond Charles Laurence Parker do pay to the Registrar of Companies his costs of the said petition such costs to be taxed on the common fund basis
