ROAD TRAFFIC ACTS

ROYTON URBAN DISTRICT COUNCIL

*The Royton Urban District Council (Various Roads,
Royton) (Traffic Regulation) Order No. 1/1974*

Notice is hereby given that on the 11th March 1974, the Royton Urban District Council made an Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to impose traffic regulations in the Urban District of Royton as follows:

1. To prohibit the loading and unloading of vehicles between the hours of 8 a.m. to 9.30 a.m. and 4 p.m. to 7 p.m. on the side of the roads or in any of the lengths of road specified in the First Schedule hereto.
2. To prohibit waiting at all times on the sides of the road or in the lengths of road specified in the First Schedule hereto.
3. To prohibit waiting at all times on the side of the road or in the lengths of road specified in the Second Schedule hereto.
4. To prohibit waiting for a period longer than two hours and return prohibited within two hours on the sides of the lengths of road specified in the Third Schedule hereto.

Exemptions will be provided in the Order to allow for:

- (a) delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953; or
- (b) loading or unloading while the vehicle is in actual use in connection with the collection or delivery of goods which cannot reasonably be loaded or unloaded outside the hours specified in this proviso provided that notice is given 24 hours in advance to the police and their consent obtained.

The Order will contain exemptions to allow vehicles to wait for as long as may be necessary for persons to board or alight, and for their use in connection with any building operation, demolition or the maintenance of essential services.

A copy of the Order and a copy of the relevant map may be inspected at the offices of the Royton Urban District Council, Town Hall, Royton, during normal office hours.

Any person who desires to question the validity of the Order or of any provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may, within six weeks from the 18th March 1974, apply to the High Court for this purpose.

The Order will come into force on 1st July 1974.
