

THE IMPORTED FOOD REGULATIONS 1968, AS AMENDED
New Zealand Official Certificate

The Minister of Agriculture, Fisheries and Food in exercise of the powers conferred on him by the Imported Food Regulations 1968 (S.I. 1968 No. 97) as amended by the Imported Food (Amendment) Regulations 1973 (S.I. 1973 No. 1351) hereby restricts recognition of the Official Certificates reproduced in Part I of the Schedule to the notice published in the *London Gazette* dated 25th August 1967 for the importation of meat and meat products from New Zealand, to the extent shown in the Schedule hereto.

The notice published in the *London Gazette* dated 12th June 1973 is hereby revoked.
