## KING'S LYNN BOROUGH COUNCIL

THE CLEAN AIR ACTS, 1956-1968

*The Borough of King's Lynn (Marlborough Park)  
Smoke Control Order 1974*

Notice is hereby given that the King's Lynn Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, on the 17th January 1974, made an Order entitled the Borough of King's Lynn (Marlborough Park) Smoke Control Order 1974, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State, Department of the Environment for confirmation.

Subject to the exemptions provided by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel or sticks and paper for the purpose of lighting. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

Copies of the Order and of the map referred to therein may be inspected free of charge at the office of the undersigned at all reasonable times during the period of 7 weeks from the 19th March 1974.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary of State, Department of the Environment, 2 Marsham Street, London S.W.1, object to the confirmation of the Order.
