

## FIRST SCHEDULE

The County Borough of Sunderland (Villette Road) (Prohibition of Waiting) Order 1964 is to be amended to provide that in the Schedule thereto there shall be substituted for the words: "Villette Road, between its junction with Ryhope Road and its junction with Hendon Valley Road", the words "Villette Road, between its junction with Manila Street and its junction with Hendon Valley Road".

## SECOND SCHEDULE

*Ryhope Road*, east side, between its junction with Matanza Street and a point 121 metres (132 yards) north of its junction with Villette Road.

*Ryhope Road*, west side, between its junction with Cedars Park and a point 78 metres (85 yards) north of its junction with The Cedars.

*The Cedars*, both sides, between its junction with Ryhope Road and a point 47 metres (51 yards) west of its junction with Ryhope Road.

*Villette Road*, both sides, between its junction with Ryhope Road and its junction with Manila Street.

*The County Borough of Sunderland (Beaumont Street) Prohibition of Waiting Order 1973*

Notice is hereby given that the Council of the County Borough of Sunderland has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit with certain exceptions the waiting of vehicles in the road or part thereof in the Schedule to this notice at any time.

Exceptions are provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle or to enable the vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to any traffic, the maintenance of the road or the services therein, or to enable goods to be loaded onto or unloaded from the vehicle.

A copy of the Order which will come into operation on 26th March 1974, and a map showing the road affected may be seen during normal office hours at Room 3.2 in the Town Clerk's Office, Town Hall and Civic Centre, West Park, Sunderland.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order you may, within 6 weeks from the date of this notice, apply to the High Court for this purpose.

## SUNDERLAND COUNTY BOROUGH COUNCIL

*The County Borough of Sunderland (Kings Avenue and Princes Gardens) (Seasonal Prohibition of Waiting) Order, 1973.*

## WHITEHAVEN BOROUGH COUNCIL

*The Borough of Whitehaven High Road Kells (40 m.p.h. Speed Limit) Order, 1974*
