The County Council of Essex (Footpaths 13 and 15), Little Easton Public Path Diversion Order 1974

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 15th March 1974, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order by the Essex County Council.

The effect of the Order if confirmed without modifications, will be to divert:

- (i) a length of the public right of way (being footpath No. 13, Little Easton) running from a point about 20 feet south of the south-western corner of Long Pond for approximately 750 feet in a south-westerly direction through O.S. field 5570 to farm gate, thence continuing south-westwards for approximately 340 feet through the grounds of the Manor, being O.S. field 4356, to the highway at the north-west corner of the Churchyard, Little Easton; and
- (ii) a length of the public right of way (being footpath No. 15, Little Easton) running from a point on footpath No. 13, which point is approximately 460 feet south-west of Long Pond, in a southerly direction for approximately 440 feet across O.S. field 5570 to the southern boundary of that field (230 feet north of the Churchyard);

to a line starting from a point about 20 feet south of the south-western corner of Long Pond and running in a south-south-westerly direction across O.S. field 5570 for approximately 870 feet to join the unaffected length of footpath No. 15 at the southern boundary of the field.
